### Step 1 – Download Application

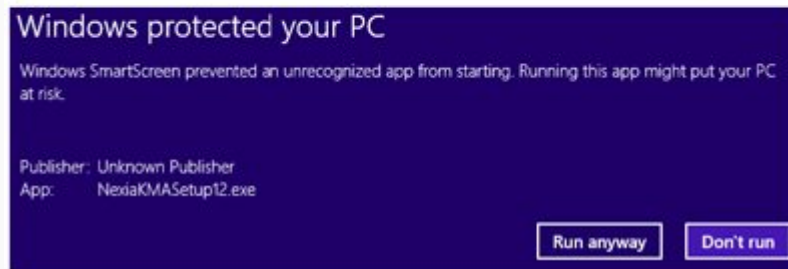
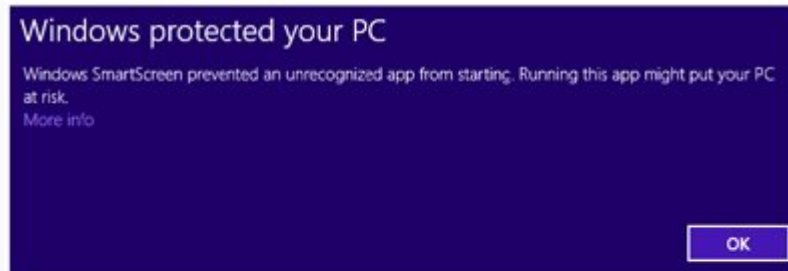

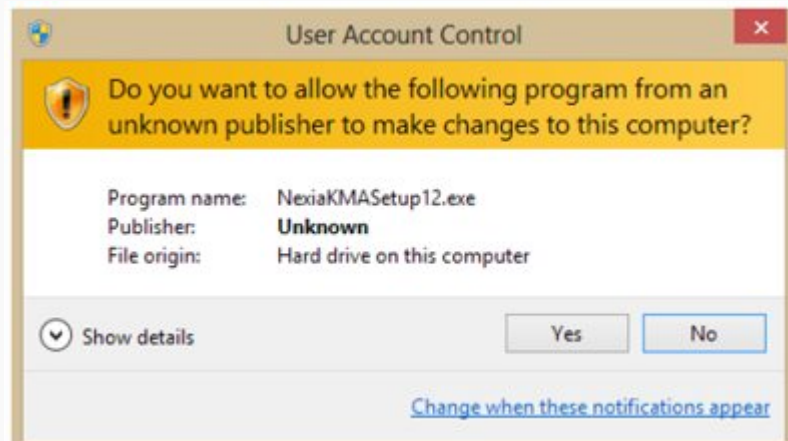
Click run as it is very small 1.4Megs there is no reason to save it first.

- This is because it is a new application and Internet Explorer’s online repository has not seen thousands of downloads of the application. It is 100% safe to run.



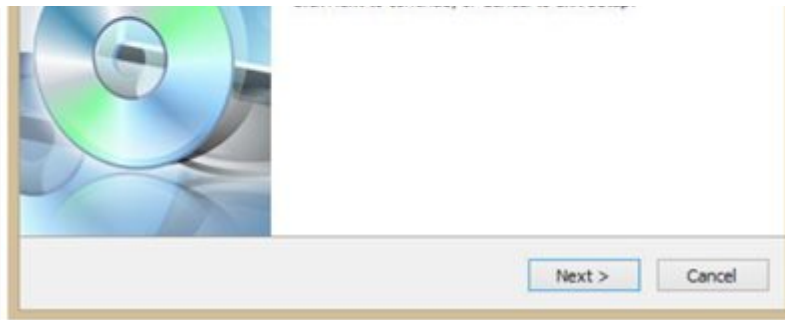
If you have UAC Control enabled you will see the UAC Box (see below) Please click Yes to continue.



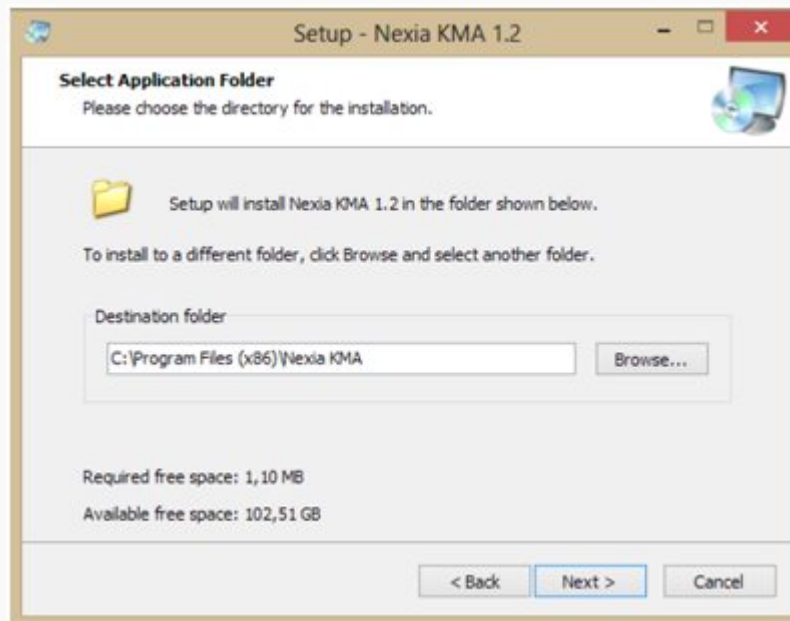
### Step 3 – The Installation

- Click Next

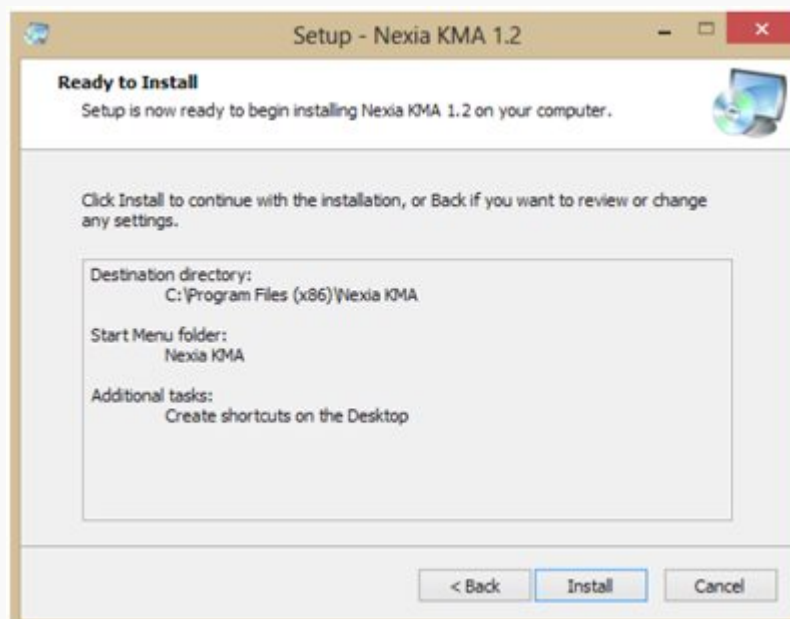




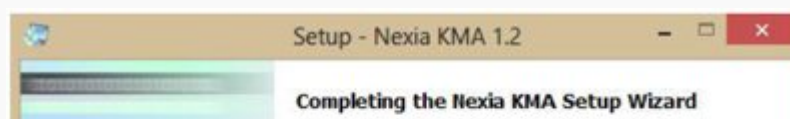
- Chose the Installation Folder: We highly recommend leaving this to the default.

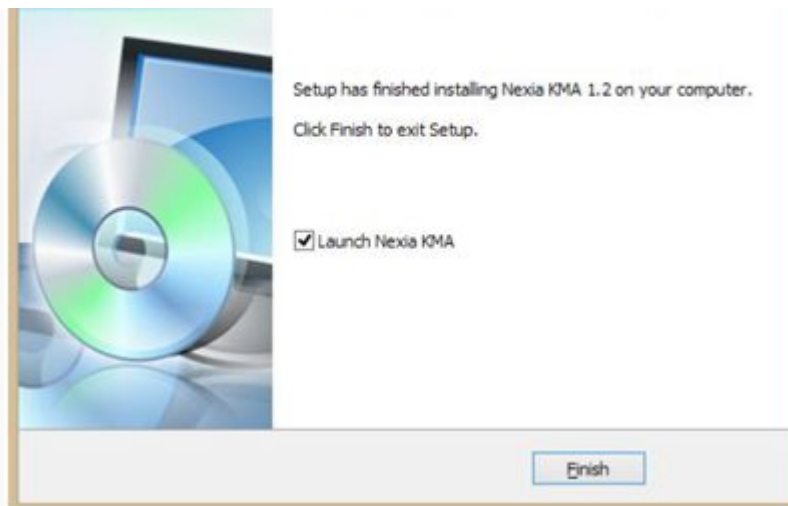


- Click Install – this will take less than a minute on a slow machine and around 10 to 15 seconds on a fast machine.

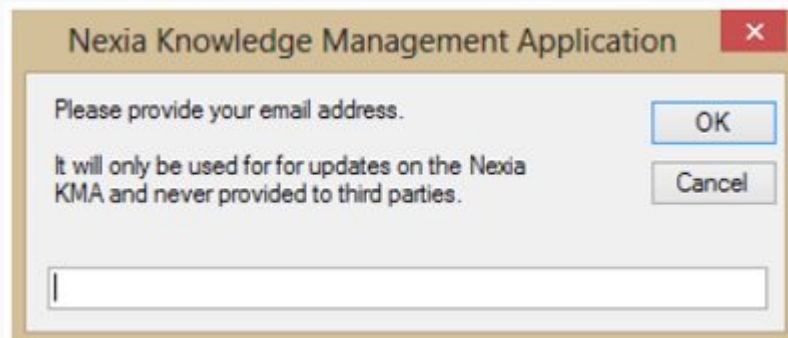


- You are now ready to run the application
