CHARTERED accounting is a gateway to a challenging and exciting career, global mobility, flexibility and great earning potential in the business field of your choice.

Chartered accountants are recognised for their technical competence and the ability to analyse and interpret business problems and develop solutions.

The minimum requirements for university admission are a National Senior Certificate with matric exemption and a Level 4 pass in maths. So, at school you need to take pure maths as a subject.

Qualifications needed: You need a BCom Accounting degree or equivalent undergraduate qualification from a South African Institute of Chartered Accountants-accredited university, followed by a Certificate in the Theory of Accounting (CTA), which focuses on

accounting, auditing, taxation and financial management. Once you have a CTA, you are eligible to enter into a three-year learnership with a registered training office.

If you study part-time, you may immediately enter into a five-year training contract with a registered training office. During your contract you must get a BCom Accounting degree or equivalent and then complete the CTA or equivalent.

Where to train: Universities accredited by the South African Institute of Chartered Accountants.

Expected earnings: The starting salary is between R20 000 and R30 000 a month. This expands rapidly with experience or specialising.

HAT does your job entail? I'm director of consulting and auditing in an audit, consulting and business advisory firm.
